ALIAS SUMMONS OR CITATIONS: \$5.00

ARBITRATION REJECTION FEES:

- Less than \$30,000.00 \$200.00
- Greater than \$30,000.00 \$500.00

CASE RECORD CHANGE OF VENUE:

- Filing Fee: Same as the original filing fee for Complaint minus the Law Library Fee of \$20.00
- Preparation and Certification of the Record to be transferred to another jurisdiction is \$40.00

COPIES:

- First page \$2.00
- Pages 2-20 \$0.50 each
- Pages over 20 \$0.25 each
- Each Certification: \$6.00
- Exemplified Copy: \$6.00

COUNTER CLAIM OR 3RD PARTY COMPLAINT:

- Filing Fee: Same as the original filing fee for Complaint being filed, minus the Appearance Fee if already paid by the party
 - **Exception:** Small Claims cases only pays for the Filing Fee

GARNISHMENTS, WAGE DEDUCTIONS, CITATIONS:

- If judgment is: up to \$1,000.00 \$15.00
\$1,000.01 - \$5,000.00 \$30.00
Over \$5,000.00 \$50.00

JURY DEMAND:

- All Civil cases: \$106.25 (6 person – excludes Small Claims)
\$212.50 (12 person)
- Probate: \$137.50 (12 person)
- Small Claims: \$12.50 (6 person)
\$25.00 (12 person)

MAILING FEE:

- \$10.00 plus current postage rate

NSF FEE: \$25.00

PETITION TO INTERVENE:

- Filing Fee: Same as the original filing fee for Complaint

PETITION TO REGISTER FOREIGN JUDGMENT OR FOREIGN SUBPOENA:

- Filing Fee: Foreign Judgment – Same as the original filing fee for the case type
- Filing Fee: Foreign Subpoena - \$339.00 (MR case type)

PETITION TO VACATE OR MODIFY FINAL JUDGMENT OR ORDER:

- Less than 30 days after entry of Judgment/Order \$50.00
- Greater than 30 days after entry of Judgment/Order \$75.00
 - **Exception:** Eviction and Small Claims – NO FEE
 - **Exception:** Petition to Reopen an Estate _ NO FEE
 - **Exception:** If modification is only regarding Child Support, Maintenance, or Withholding Order – NO FEE

PROBATE ESTATE CLAIMS:

- Claims: \$0.00 to \$150.00 No Fee
- \$150.00 to \$500.00 \$25.00
- \$500.01 to \$10,000.00 \$40.00
- Over \$10,000.00 \$60.00

RECORD SEARCH:

- Record Search for each year: \$6.00
- Reproduction of any record: Regular copy fees apply
- For a single Plaintiff/Defendant or a single case inquiry made in person with no request for copies where the case is maintained on PC JIMS – NO FEE
- Printouts for Child Support or Spousal Support Record – NO FEE
